Please be aware there may be a fee for a hard copy of the Documents. Please understand that these Governing Documents are primarily in place in order to retain an acceptable and uniform standard that protects the quality of living and maintains the marketability of the community.

Your maintenance fee of **\$155.00** is due **monthly**. Since efficient and timely processing of your maintenance fee is critical to the accuracy of your account, payment should be made by mailing your coupon and check directly to your association bank. If you did not receive a coupon book at closing, please call Ameri-Tech Community Management, Inc. at 727-726-8000 and one will be ordered for you. If auto pay is something you would be interested in doing, we have enclosed the form necessary to initiate that process.

**You can register at Shadow Run's website (as stated above) for any alerts and important information from your Association.**
