Section 23(I) of the Declaration is **created** to read as follows:

## I. Leasing.

- (a) Term of Ownership Before Leasing. The owner of any unit must own the unit for two years before it is leased or rented. This provision does not apply to the Association when it takes title to a unit by foreclosure or deed in lieu of foreclosure.
- (b) No Owner may rent his lot if, at the time he desires to enter into a lease or lease renewal, the Owner is not current on all assessments.
- (c) The Board shall have the power to adopt rules to maintain the integrity of these provisions.
